- Tiroa E & Te Hape B Trusts; Governed 7,000 hectares of a beef & sheep farm with an asset base of 1 billion dollars and purchased the neighboring Te Awa Rua farm block (1,100 hectares) for \$11 million, returning whenua to Māori ownership we also received \$2 million from MBIE to fence of waterways and develop the Waitara Nursery with native plants.
- 2015 – Trustee for Waihaha 3D2 forestry block sold Carbon Credits and made \$1 million .
